

Benzina Zero V 10 E-Scooter GIVEAWAY TERMS & CONDITIONS

Introduction

By participating in the giveaway, you are agreeing to these giveaway terms and conditions. The giveaway is being run by Road Accident Action Group Inc. (RAAG).
